## NOTES TO APPLICANTS:

- This Call for Expressions of Interest concerns all regions of Sudan, all suppliers that are legally registered in Sudan and operating in those fields/categories (mentioned above), are invited to express their interest.
- All vendors that are already registered with IOM SUDAN are strongly encouraged to re-register themselves in the system to receive future invitations
- All eligible suppliers and services providers for supplies/services which are not listed above are also strongly encouraged to submit their EOI for the introduction of their business and registration.
- Suppliers must specify the areas of intervention (Location) of their activity (e.g., Northern State, Kassala State, Red Sea State etc.). Those who work in several regions/states can specify them in the submission form by indicating the address of their representation in these regions.
- Each submission will be evaluated by IOM and included in the new database depending on the results of the evaluation.
- The submission of a registration application does not guarantee automatic registration in IOM's supplier database.
- The inclusion of companies in IOM's supplier database does not mean that you will be consulted in all solicitations/RFQ/ITT issued. This only means that your company, once included in the database, will be treated equally in the company selection process in accordance with IOM's procurement procedures.
