# **Background and rationale:**

IOM has formulated a comprehensive strategic approach centered on the 3Es for action: to enable, engage and empower diaspora communities, and promote them as agents for development with each area involving a range of interventions by governments and other stakeholders, supported by IOM through policy advice and programming.

Diaspora engagement has always been a priority to the government of Sudan as there are many Sudanese living abroad estimated at four to five million. Their expertise and contribution can support tremendously in the development of the country through the transfer of knowledge and financial contributions.

Working with diaspora continued to be a priority during the transitional period in 2019 in connection with development of Sudan. During the UN General Assembly in 2019, the previous Sudanese Prime Minister addressed the UNDP and requested their support to improve diaspora engagement efforts in Sudan. Furthermore, the former Acting Minister of Foreign Affairs addressed IOM's Director General in September 2020 requesting IOM's support to the government in this regard as well. In May 2021, IOM organized a high-level delegation visit to Sudan from its Regional Office (RO) in Cairo and Headquarters in Geneva to assess the needs and readiness of relevant government agencies in terms of diaspora engagement.

Through its global network, IOM improves the links between the Sudanese diaspora abroad and the institutions in Sudan, by building a network, enhancing the dialogue and bringing new opportunities through skills transfer and financial investments to contribute to the socio-economic development in Sudan.

As the UN Migration Agency, IOM Sudan has played a significant role in facilitating engagement between the Sudanese diaspora and Sudan. IOM Sudan had several initiatives engaging the Sudanese diaspora in building capacities of national institution. IOM implemented the Temporary Return of Qualified National (TRQN) from 2006 – 2012 and 2014 - 2016 through which Sudanese experts from the Netherland and other EU countries contributed to the advancement of the government and non-government institutions through the transfer of knowledge.

Diaspora always showed their willingness to help the country, but they lacked the information and the means on how to support and where the support should be directed. In 2021, IOM conducted a scoping mission to the UK to meet with diaspora groups and members to understand their interest in contributing to the country as well as the interest of the second and third generation. One of the common issues was lack of information such as priority sectors and how they can contribute including transfer of knowledge or investment mechanisms.

In order to address this gap and produce evidence-based data for diaspora engagement programming in the future, IOM is seeking to hire a national consultant to conduct an assessment on main sectors that would benefit from the contribution of the diaspora and asses the means to facilitate their financial contribution for investment.

# **Core Functions / Responsibilities:**

Under the overall supervision of the Chief of Mission and Deputy Chief of Mission, IOM Sudan and the direct supervision by the Migrant Protection and Labour Migration (PXD/LMI) Programme Coordinator and in coordination with the Technical Working Group (TWG), the Consultant will perform the following tasks:

- Develop a workplan on the deliverable and methodology of the assignment.
- Desk research on the exiting materials such Sudan National Plans, Interim Cooperation Framework (ICM 2024 2026) which identify the gaps and needs in main sectors in the country. Also, assess national policies, strategies and regulation that promote diaspora's engagement for investment and development.
- Conduct Key Informant Interviews with the selected priority sectors that will benefit for diaspora's contribution.
- Draft a white paper on the finding of the assessment.
- Present the finding in a workshop to relevant stakeholders.
- Submit the final report reflecting the recommendations from the workshop.
